

**E. Glenn Moore/James L. McIntyre
SCHOLARSHIP GUIDELINES 2018**

1. Each year Long Reach Federal Credit Union will award to **two** graduating seniors who have been accepted at an accredited school of learning such as a college, university, trade school or institution offering student training programs, a \$1,000.00 scholarship.
2. In order to qualify for the scholarships, the students must be a member of Long Reach Federal Credit Union and must have submitted the required application forms. The student must be enrolled full time at the time of receiving the scholarship.
3. Scholarship applications will be judged by an independent judging committee, excluding Long Reach Federal Credit Union board members. Awards will be presented at either the high school award ceremony or at the graduation.
4. The award will be given in two installments of \$500.00, one in July and one in December. To be eligible for payout, the student must show proof of enrollment in the form of a tuition bill from a qualified institution. The award will be deposited in the winner's account at the Credit Union.
5. Winning entries will be judged on involvement in school activities, community participation, adult or teacher recommendation, and essays the student will write.
6. The scholarship committee will be appointed by the board president in consultation with the board of directors. The committee shall consist of no more than five (5) and no less than three (3) people.
